He reported that there was multiple records/letter back and forth. “Bad outcome is not my expertise in wound care.” He suggested that a Podiatrist or the Medical Board be asked to look into this complaint. There are three Guam licensed Podiatrists, not currently on Guam to look at this Complaint. They are Dr. Palmquist, Dr. Lilly Shimahara, and Dr. Tutnauer. Dr. Miller said that his tenure on the Board is up in February. The Chair asked Dr. Miller to look into the detail of the work required and the costs; and to prepare a letter soliciting these Podiatrists’ participations to assist the Board and a proposed fee. Legal Counsel noted that before soliciting off-island experts, the Board should first discuss costs with the Administrator of HPLO. Some Boards’ Members discuss the merit of the case openly. Board members must limit public exposure on the case, being reviewed and investigated. It is the Board’s duty to accept or reject charges on accusations and whether the charges can go forward. If so, then a Hearing Officer is assigned to the case. A Board Member, whose term is expiring, can continue to serve on a case even if his/her term expired. Anticipating that when more complaints are filed, the Board has to talk about the merit of the complaint <b>first BEFORE</b> discussing the case in public.</p> <p>2) 2020-12 Patricia Roberts against Kevin Malakooti, DVM Dr. Paul Pomes reported on the Complaint, a post-surgery wound.
