A.6- This is the testing that we do and can share results:

- Sieve Analysis of Aggregate
- Moisture Content of Aggregate
- Compressive Strength of Concrete Mix per ASTM standards.
- QC Inspections (stressing and strand elongation, pre-pour, post-pour, post-finish, preship)
- Pole destruction testing at an independent laboratory
- Full traceability on each pole

Do the engineers want to perform an audit of our facilities?

Do they want to purchase a pole for destructive testing purposes?

Is it sufficient to have an independent lab perform testing on their behalf?

What testing are they specifically looking to perform?

ANSWER:

A.7- Bidder shall also be responsible for airfare expenses, ground transportation, hotel lodging and meals for two (2) GPA Representatives.

In addition, two (2) GPA Representatives will witness pole testing at the pole factory.

- No. The successful bidder shall be responsible to provide all poles for testing. GPA will randomly select poles form the batch manufactured for GPA. The manufacturer must furnish two (2) extra poles for destructive testing.
- No. GPA shall witness all tests.
- Refer to GPA Specification E-035, Rev.2 for test setup and procedures.

Note: GPA stands firm with GPA Specification E-035, Rev.2 in its entirety and shall not be altered.
