Delivery Time Extension for Ocean Freight option.

- This is to request for an amendment on the delivery time from "10 weeks" to "14-16 weeks". The manufacturing time for these parts are 8 weeks not including customs clearance & transit time for ocean freight which is an additional 6-8 weeks.
