GVB OFFICIAL RESPONSE TO ADDITIONAL QUESTIONS RECEIVED RELATIVE TO GVB RESPONSES TO QUESTIONS AND ADDENDUM NO. 6 DATED FEBRUARY 20, 2023:

The Guam Visitors Bureau advises that Amendment No. 7 is issued to provide an official response to additional questions received that are pertinent to this procurement.

From GTA received February 20, 2023:

- 1. Referencing bid schedule page 47 "Communications (Landline), please clarify:
 - a. For the additional telephone lines, please advise if the quantity should be 1 line.

GVB RESPONSE: Yes, pricing is for 'each' (one line) in order to determine costs for future line expansion as needed.

b. For the additional telephone lines, please if this should be part of the total 12-month pricing. If this additional line is for future requirements or requests, please advise if this can be removed from the total bid pricing

GVB RESPONSE: Yes, please keep these prices separate from the TOTAL BID COST (on page 48). It will only be used for costing for future expansion as needed.

c. For the additional dedicated lines, please advise if the quantity should be 1 line.

GVB RESPONSE: Yes, pricing is for 'each' (one line) in order to determine costs for future line expansion as needed.

d. For the additional dedicated lines, please if this should be part of the total 12-month pricing.

GVB RESPONSE: The additional dedicated lines on page 47 (last two rows) are intended for information only when costing for future expansion. It should not be included in the TOTAL BID COST.

- 2. In reference to Addendum 5, RFI Response #27.
 - a. If the Mobile DECT units do not require DID capabilities, how will they be utilized?

GVB RESPONSE: The mobile DECT units will be used by assigned staff-members or event-organizers during special events for sending and receiving internal (extension to extension) calls from GVB HQ in-house desktop units for immediate communication on the premises. The units must also be able to send and receive calls from one another, i.e., from extension to extension (in-house).

The Guam Visitors Bureau advises that Amendment No. 7 is issued to provide adequate time for bidders to review all GVB responses to questions.

Participants shall refer to the AMENDED GVB IFB 2023-001 for the Scope of Work and General Specifications and Bid Schedule relative to the submission of their bid.
