GENERALS:

These specifications have been written to describe minimum equipment & performance requirements to be supplied by the equipment manufacturer bidding. Reasonable test may be conducted upon delivery before acceptance.

The successful bidder shall furnish all necessary & appropriate information & instructions for the proper operation of the equipment. The government reserves the right to accept and/or reject any & all bids, to waive any defects, irregularities, or specification discrepancies & to award the bid as council deems to be in the best interest of the government.

Each vehicle shall be new / unused, current or later model year production. Each vehicle shall be supplied with all standard equipment & accessories indicated in manufacturer's published literature/brochure unless specifically deleted as stated in this specification. Optional equipment necessary to meet the requirements of this specification shall be installed.

BRAND NAMES:

Manufacturers' brands & stock/part numbers specified do not denote a preference for that make, but specify the level of quality necessary. Alternate brands found to be equal to or greater in quality to the brand specified may be accepted, however, the burden to prove equality shall rest with the bidder.

The subject specifications were drafted to allow for reasonable bid competition, however, needed to be tailored to meet the needs of the Government of Guam. The minimum requirements specified were established through market research of product availability & capabilities with references & or recommendations from local dealerships. The specifications were based on the following makes & models: **GMC Sierra 1500, Ford F150 & Dodge Tradesman 1500.**

Engine: Gasoline, liquid cooled, electronic fuel injection, emission control.

Payload Capacity: 1,430 lbs. minimum

Conventional Towing Capacity: 8,000 lbs. minimum.

Overall Length: Shall be no longer than 250 inches maximum, bumper to bumper

Cab: 4-door (front-hinged) crew cab. Side steps or running boards on both sides shall be installed.

Seating Capacity: 6-passenger seating shall be provided.

Interior Features: Heavy-duty vinyl / rubberized flooring & vinyl seating preferred. Carpet flooring & cloth seating shall include: all-weather floor matting that meets FMVSS302 & ISO9001 standards & heavy-duty water proof seat covers (Neoprene) installed. (Black colored mats & seat covers).

Bed: Standard bed option, spray-on type rhino liner or equal or composite bed with lifetime guarantee. Plastic bed liner inserts are not acceptable.

Bed shall have adjustable cargo tie down cleat system.

Bed Length: Shall be 76 inches minimum or 79.44 inches max.

Bed Slide Tray: 1,500 lbs. capacity with slide lock & pull handles, shall be equipped with rubberized deck, cargo side rails & tie-down system to secure cargo. (Ref: Cargo Glide brand, model #CG1500 XL).

Bed Cap: Vehicle shall be delivered with a bed cap (same color as vehicle), installed & equipped with the following features: (Ref. Leer brand, model #100R or equal).

- Removeable clamp on type mounting with bed rail mounting gaskets
- Solid sides (no side windows or side doors)
- Water tight, bulb seal installation
- Cab high type, Height shall be aligned with top of cab
- Width & length shall match the cargo bed.
- Fiberglass construction
- Commercial cap structure reinforcement
- Fiberglass base rails
- Dupont quality or equal automotive paint
- Interior headliner
- Interior dome light
- Recessed third brake light
- Radius fixed front window
- Lockable rear door, recessed, dark tinted glass with screen
- Double T-handle latches.

Electrical System: 12-volt battery & alternator.

Transmission: Automatic.

Brakes: Power assisted.

Steering: Power assisted with tilt adjust steering wheel.

Tires / Wheels: Manufacturer standard sized all-terrain tires shall be provided. Polished alloy wheels are acceptable but not required.

- Including the spare, 5 ea. tires & rims of identical size shall be provided.
- Tire width shall not extend past fenders or flares.
- Front & rear mud guards shall be provided.
- The vehicle shall be equipped with front suspension & engine skid plates.
- 2 ea. front factory installed fog lights shall be provided.
- Electronically controlled differential lock with limited slip feature shall be provided.
- Transfer Case: 2-speed 4WD ratios with auto

locking hubs.

Color: White, if available.

Undercoating: Full rust proofing with a 10-year guarantee or electric rust control with lifetime guarantee.

Required Accessories: Air condition, AM/FM radio, rear view mirror, jack & lug wrench, side view mirrors, full tank of fuel, mounting hardware for license plates.

- Factory installed, hands-free cellular communications capability.
- Reverse camera & monitor system with back-up sensors.

Towing Package: Tow Receiver: Frame mounted class IV tow receiver with an adjustable height, combination pintle 2" ball type hitch. Wiring harness with 4 & 7 pin connectors & applicable converter.

When available as manufacturer options - Hill start assist, trailer brake control & trailer sway control features shall be provided.

Vehicle shall be equipped with an adequate cooling system for engine oil, transmission & power steering fluids.

Vehicle Marking: (Upon Delivery) Vehicle shall have visible adhesive markings on both sides. Marking shall include the following: GSWA logo with dimensions of 12" x 12". Contact GSWA representative for logo.

SERVICE / MAINTENANCE & REPAIR

MANUALS: The successful bidder shall provide (1) complete set of the most current service / shop repair manuals Book Form or CD ROM or access to them electronically at no additional cost during the life of the vehicle. Manuals shall cover the entire vehicle to include: Engine, Transmission, Body, Chassis, Wiring locators / diagrams & all parts manuals associated with vehicle. If this cannot be provided, relative technical assistance shall be provided through the life of the vehicle / s at no cost to the government. Statement of compliance shall be present at time of vehicle delivery.

SERVICE REQUIRED: Manufacturer's recommended preventive maintenance as defined by the manufacturer's scheduled maintenance guide shall be performed through the duration of Manufacturer's powertrain warranty, all parts, labor & disposal fees included at "No Cost to the Government of Guam". No less than 5 years or 60,000 miles Whichever comes first. (Documentation / Service contract shall be included with the delivery of vehicle).

WARRANTY: (All guarantee, warranty, & service periods begin on date of delivery).

The successful bidder shall guarantee all parts, components, materials & workmanship associated with the vehicles delivered to be free from defects for the period of (1) year /12,000 miles starting at the date of delivery. Unlimited to include lights, fuses etc. Unless defect is determined to be caused by obvious operator negligence.

The successful bidder shall also provide the manufacture's standard warranty. Certification of warranty & its limitations shall be provided upon delivery of vehicle. No less than 3 years 36,000 miles bumper to bumper, 5 years 60,000 miles power train.

The successful bidder shall be fully responsible to entertain, address, negotiate & schedule any & all warranty related issues whether in house or with outside vendors.

The successful bidder shall provide service such as diagnostic, repair or adjustments of the vehicle on government premises or field location. If repair cannot be done on location, bidder shall have vehicle transferred to shop where repair can be executed at any time within the warranty period.

Vendor shall record mileage accumulated prior to delivery. The recorded mileage shall be added to mileage limitations for all warranty & service periods.

WARRANTY & SERVICE CONDITIONS:

The successful bidder shall be responsible for all cost associated with warranty & service. To include but not limited to: Transport, diagnostic, parts, labor, disposal etc.

During warranty period, the Government of Guam will not be liable for diagnostic fees not covered by warranty. Exception: Defect determined to be caused by obvious operator negligence.

All warranty & maintenance services shall be performed by manufacture / factory trained, authorized technicians.

Due to nature of services provided by the Government of Guam all maintenance & warranty repairs shall be subject to priority scheduling & performed expeditiously.

If the vehicle is out of service for (3) three consecutive days or longer awaiting parts, service or repairs, the total amount of time shall be added to existing warranty period.

Through the duration of Warranty periods specified, if vehicle is out of service pending parts or repairs for three (3) consecutive days or longer, an equivalent loaner vehicle shall be provided at no cost to the Government of Guam. A Base 4x4 crew cab pickup will satisfy this requirement.
