#### QUESTION:

- 1. With regards to the Bid Bond, we have never had to provide this for any of our training customers in the past. First off, is this really required for this type of service, and if so, what numerical amount of money would be required in this bond?
- 2. The Ownership & Interest Discloser Affidavit as well as the Non-Collusion Affidavit require signature verification from a Notary Public, but the No Gratuities or Kickbacks Affidavit requires a Notary Public in and for the Territory of Guam. Does this require Notarization from someone authorized in Guam, or would any Notary Public satisfy this requirement? The same applies to page to the affidavits on pages 18 and 19.

#### ANSWER:

- 1. Yes. Pursuant to Public Law 27-127, all competitive sealed bidding for the procurement of supplies or services exceeding \$25, 000.00 a 15% Bid Security of the total bid price must accompany the bid package. Kindly refer to Page 2 of 39 Special Reminder to Prospective Bidders and Page 33 of 39 under the Government of Guam General Terms and Conditions No. 11.
- **2.** Yes. This is to confirm any Notary Public shall suffice this requirement. Kindly refer to Page 2 of 39 Special Reminder to Prospective Bidders.
