QUESTION:

This is in regards to GPA-071-24, GPAIT Converged Compute/Server Solutions, specifically the VMware software component included (Section C. SOFTWARE AND LICENSING REQUIREMENTS).

Due to the acquisition of VMware by Broadcom, unforeseen events have transpired starting APRIL 30, first the change in licensing model and product SKUs, which makes the bid requirement obsolete; second is the significant pricing changes due to the licensing model change; third is the indefinite time frame on the freeze on all sales-related transactions from quote requests to closing a sale, making the task of accurately pricing VMware impossible at this time.

Although requesting for another extension would be the usual route to take, we would like to request if the end-user could assess the situation and lay out what would be the best course of action to take.
