B.14 transformer dewpoint sensor makes more sense on the stand alone vacuum pump skid, not on the degas skid. Need clarification

B.6.2 Please also confirm that we were going to supply the second standalone vacuum package with a metal roof and roll up canvas sides to cut down on weight. It is transported inside the main 20ft container so it should have adequate protection. If they really want to have the metal enclosure I can do it but it adds cost and weight. Please confirm with customer.

ANSWER:

B.1 Steel container is fine as long as it is constructed of marine-grade corten steel.

B.2 Acknowledge, the chassis for the container will not be required.

B.14 Acknowledged, dew-point sensor will only be required on the stand-alone vacuum system.

B.6.2 Metal enclosure will be required for the stand-alone vacuum system. During its operation, it will be removed from the container and be exposed to the tropical elements.
