#### QUESTION:

1. Guam Power Authority sent out an Amendment IV on June 11, 2024. On the amendment it states that part of the bidder's scope is to clean the following Lube Oil tanks:

455 Gallons of Lube Oil per Caterpillar Engine, a total of 8 engines.

880 Gallons of Lube Oil per Wartsilla Engine, a total of 2 engines.

Are these tanks above surface tanks (AST)?

Can we clarify what is meant by "cleaning"?

Does this mean to just drain the pre-existing oil?

Or does this mean to drain and pressure wash with water?

Or is there another method of cleaning that is required?

We were told that water washing is not recommended but we wanted to understand if this is a requirement from GPA.

## ANSWER:

Yes. These tanks are above surface tanks (AST).

The drainage of the pre-existing oil shall be the responsibility of the awarded Contractor.

#### QUESTION:

1. On page 11 of 46, the RFP requests "audited" financial report

Question: Considering that "audited" financial reports take roughly 3 to 6 months to prepare we would like to request that "compiled" audited reports will suffice.

#### ANSWER:

Yes. Audited reports prepared by a certified public accountant (CPA) is acceptable.

### QUESTION:

- 2. GPA requires the following documents for Technical Proposal:
  - a. Business Structure and Business Approach
  - b. Experience and Qualifications
  - c. Statement of Qualifications/Organizational Structure
  - d. Product and Quality
  - e. Financial Information
  - f. Federal and Regulatory Compliance
  - g. Client References
  - h. Mobilization Capability

Question: Considering that total volume per year is less than 2 containers worth of product, we would like to request if Client reference letters (section g) can be removed for the technical submissions as client reference letters may take longer than the bid submission date.

### ANSWER:

No. Client reference letters must be submitted.

#### QUESTION:

1. What is the ODI (Oil Drain Interval) schedule per site?

### ANSWER:

Oil drain interval is only measured by the running hours of each engine. Every 2,000 hours an oil change maintenance is performed in which oil is drained from engine and replace with new oil.

#### QUESTION:

2. Because the fuel used in ULSD, is GPA using any type of exhaust emission system?

#### ANSWER:

Yes. GPA fast track units use a Miratech Diesel Engine Oxidation Catalyst System.

#### QUESTION:

3. Will there be a scheduled site visit prior to bid closing?

#### ANSWER:

Refer to INCLUSIONS No. 1 and 2 above.

#### QUESTION:

4. Referencing Scope of Work 2.3, the initial service to clean the engine holding tank, will this be at the expense of the offeror/contractor?

# **ANSWER:**

The initial service is to be performed and engine holding tank is to be cleaned at the expense of the contractor. This requirement will ensure the quality and integrity of the product and service provided will be properly enacted from the onset of the contract.

#### **QUESTION:**

5. Per the Scope of Work there will be a reduction in volume from contract year 1 to contract year 2 of 25%, and then again between contract year 3 and contract extension year 1 of 33%. What are the drivers of these reductions in consumption?

### ANSWER:

The progressive reduction in volume consumption between years is based on the projected reduction in load that the fast track diesel generators will be required to operate. As the new Ukudu baseload power plant comes online, our backup diesel generators will be required to run less, therefore reducing the amount of oil needed each year.
