QUESTION:

1. I wanted to clarify if the bid guarantee (15%) would be in relation to all 3 contract years (1 required + 2 option) or ONLY the Required Contract Year 1?

ANSWER:

The 15% Bid Guarantee requirement is only for the required Contract Year 1.

Bidder No.: 6 dated 04/17/2025:

QUESTION:

1. We would like to request for an extension on the submission deadline of GPA-041-25. We are also requesting for an Online Teams Meeting to discuss the details of the requirements with regards to storage space requirements and we would also need to know how many CPU sockets and cores each node consists of. Further, we would need to know how many nodes there are (different packages available, dependent on over all requirements).




ANSWER:

Please refer to **CHANGES** 1 & 2.

As indicated on GPA-041-25 bid specification A.1, GPA is seeking for enterprise level backup application software solution only. Storage space requirement is irrelevant as GPA will utilize its own storage space to store backup images.

Bid specification A.1 also indicated that GPA is seeking for backup solution for 300 individual nodes. Within our VM environment, each of these nodes is considered on single socket CPU with two cores processing power.

All other Terms and Conditions in the bid package shall remain unchanged and in full force.
