QUESTION:

- 1. Below are the following questions Bidder No. 5 would like some clarifications on:
 - A.1 states "Lighting and reflective package including reflectors, markers, and clearance lights shall be provided that meet federal regulations." Is this an additional part/s that is required to be installed onto vehicle? If so, could you provide reference to match division requirements?
 - E.7 states "All warning, safety and identification decals to meet federal standards and requirements." What are the required dimensions of decals that are needed to be placed on vehicle? Are there specific colors that are needed?
 - E.8 states "All warning and safety devices to meet federal standards and requirements." Specifically what devices will the division need to be installed onto vehicle and could you provide a reference to match division requirements?
 - Requesting for additional 2 weeks extension for bid submission upon response to questions.
