Bids will be publicly opened in the Procurement Conference Room, 1st Floor, Gloria B. Nelson Service Building, 688 Route 15, Mangilao, Guam.

Contract time is <u>240 calendar days</u> after issuance of Notice to Proceed. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Bid security can be made by a surety bond or cash deposit in the form of a certified check or cashier's check made payable to the Guam Power Authority.

All interested parties are hereby notice that minority business enterprises will be afforded full opportunity to submit bids in response to the invitation and will not be discriminated against on the grounds of race, color and national origin in consideration for an award.

The right is reserved to reject any or all bids and to waive any imperfection in the bids in the interest of the Guam Power Authority.

A pre-bid conference will be held on <u>June 12,2025</u>, <u>10:00</u> a.m. at the GPA Procurement Conference Room, 1st floor, Gloria B. Nelson Service Building, Mangilao, Guam. A site visit to allow prospective bidders to familiarize themselves with said project will be conducted after the pre-bid conference.

INSTRUCTIONS TO BIDDERS

RECEIPT AND OPENING OF BIDS

★ Interested parties shall submit two (2) copies and one (1) original of their sealed bids for the Gloria B. Nelson Public Service Building – Physical Access Control System Replacement (Design-Build) project to the Guam Power Authority's Procurement Office, located at 688 Route 15, Mangilao, Guam, no later than 9:00 A.M. August 01, 2025. Bids will be publicly opened in the GPA Procurement Conference Room, 1st floor, Gloria B. Nelson Service Building, 688 Route 15, Mangilao, Guam.

Bids shall be made on the forms furnished by the Guam Power Authority and shall be enclosed in a sealed envelope addressed to the General Manager of Guam Power Authority, Procurement Office, 688 Route 15, Mangilao, Guam and endorsed with the name of the bidder and the title "Gloria B. Nelson Public Service Building – Physical Access Control System Replacement (Design-Build)". Attention is called to the fact that bidders not only offer to assume the obligations and liabilities imposed upon the Contractor in the form of contract, but expressly make certain of the representations and warrants made therein. No effort is made to emphasize any particular provisions of the contract but bidders must familiarize themselves with every provision of the contract and its effects.

TIME OF COMPLETION

The Contractor shall commence work on the date specified in the Notice to Proceed and shall complete all work within <u>240 calendar days</u>, complete and ready for use. In the event the Contractor does not complete the work within the time specified, liquidated damages will be assessed as stated in Section 5 of the Special Provisions.
