QUESTION:

1. The recently released Amendment 2 has changed the bid specs entirely. We configured a quote for a "1-Ton" truck as originally requested, and since this is no longer required, we now have to start from the beginning. The new requirements will now require a lager truck frame, which requires us to reconfigure the flatbed, and also now require a new freight quote.

Due to the changes from amendment 2, we request that the bid opening date be extended rom 09/17/2025 to 09/30/2025 to ensure that we have enough time to properly quote an entirely new vehicle.

Additionally, can you confirm that only a 14ft length flatbed is still required for a truck that has this large of a capacity?
