#### QUESTION:

1. May we submit our bid without the required affidavits, bid bond, and other attachments, if we will only be working under a Purchase Order basis (just a full maintenance contract)?

#### **ANSWER:**

No. Failure to comply with the requirements on Page 2 of 33, "<u>SPECIAL REMINDERS TO</u> **PROSPECTIVE BIDDERS**" will mean a disqualification and rejection of the bid.

#### QUESTION:

 Our intent is to provide services only for the Fire Alarm System and not for the Wet Sprinkler System. Please confirm if partial participation or quotation for the Fire Alarm System only will be accepted under this solicitation.

#### **ANSWER:**

No. The award is based on total lump sum bid and not an itemized award.

#### QUESTION:

3. We would also like to request a **bid opening date extension to November 20, 2025**, to allow sufficient time to prepare the required documentation.
