QUESTION:

2. Our intent is to provide services **only for the Fire Alarm System** and not for the Wet Sprinkler System. Please confirm if partial participation or quotation for the Fire Alarm System only will be accepted under this solicitation.

ANSWER:

No. The award is based on total lump sum bid and not an itemized award.

QUESTION:

3. We would also like to request a **bid opening date extension to November 20, 2025**, to allow sufficient time to prepare the required documentation.
