## Bidder No.: 2 dated 05/29/2025:

### QUESTION:

- 1) In reference to C.2.1 Monitoring of Security Surveillance (CCTV) and Alarms at GPA Security Operations Center.
  - a) Will GPA provide the cameras and alarm systems at each site required to be monitored?
  - b) Will GPA provide all equipment necessary at Fadian to complete this work?
  - c) Will GPA provide training to use their CCTV and Alarms at Fadian?
  - d) Is this quote only for manpower?
- 2) Gate safety is important. It was noted during inspection that some gates are broken and have been reported to GPA for repair. To ensure staff safety from hazards, we request confirmation that GPA will fix gates when issues are reported to prevent injuries.
- 3) On page 28, does the Executive Order 14026 apply?

### ANSWER:

- 1. a) Yes. GPA is deploying cameras and alarm systems via a separate project.
  - b) Yes. Again under a separate and on-going project, all cameras, alarm sensors, networks, monitors and equipment are in process of being completed.
  - c) GPA will provide in-house training at the time we elect to engage in monitoring option.
  - d) Yes. This is for manpower only, and again is an option we will elect to invoke when we are ready with the installed equipment on our end.

- Yes. GPA is currently working at addressing these issues for repair and will continue to do so as needed for the Safety of all individuals, contracted vendors, Authority personnel and/or customers that may be affected. We are also specifically working on the respective guard post shacks that cover this contract.
- 3. Executive Order 14026 is titled "Increasing the Minimum Wage for Federal Contractors". The Declaration Re-Compliance with U.S. DOL Wage Determination Affidavit and attachments are made a part of this IFB in compliance with the Attorney General's Office.

All other Terms and Conditions in the bid package shall remain unchanged and in full force.
