1. May I request for a change of delivery requirement from 32 weeks ARO to 130 weeks ARO. Below is the comment from the manufacturer:

Note that they request 32 weeks delivery. This is impossible for us to meet, and I believe it is shorter than any other vendor on the market is offering. Demand is high, and we are running an 18-24 months backlog currently

We are requesting for 130 weeks, as we have to factor in the shipping (ground and ocean, delivery and receiving).

2. I'm writing to request a two-week extension to the bid opening.
