The Guam Board of Medical Examiners Chairperson, Nathaniel Berg, MD called the meeting to order at 4:32 pm on March 14, 2018 at Guam Memorial Hospital Board Room.

Dr. Berg, stated that Dr. Bellis's (Psychiatrist) evaluation report saw no problems at least of the time being under the provision that he will not work extended long hours. Dr. Easow, as a provider, has acknowledged working long hours was a problem but has not heard a single complaint regarding any patient care issues. He also stated that the only thing missing were the other two evaluations. Dr. Berg was inclined to allow Dr. Easow to work under the provision as directed by Dr. Bellis and suggest for a period of six months, then be reevaluated for whomever he is working with without any restrictions.

Dr. Gill asked Dr. Easow to explain the evaluation report from Dr. Carlos, since no report has been submitted. He mentioned that Dr. Carlos had cleared him for neurologic or memory problems. The computer test that he took had a lot of questions with certain things you had to remember. He admitted not being able to remember everything correctly. Verbally, he and Dr. Carlos did well. The test he took is called neuro trac test. Dr. Gill stated that Dr. Bellis found no psychiatric issue.

Dr. Rahmani volunteered for Dr. Easow to touch base with him on a monthly basis for a period of six months when he's employed and licensed. Dr. Easow orally stated that he's offered a part-time job with American Medical Center and also applying at IHP Medical.
