Annual Report to the Guam Board of Nurse Examiners

Report Period:

July 31, 2019 - July 31, 2020

Certified Nurse Assistant, Industry Certificate

As a result of the COVID-19 pandemic Guam Community College's Certified Nurse Assistant program has only minor additions to report to the Guam Board of Nurse Examiners since the submittal of our bi-annual report on December 31, 2020. Following the submittal of our report, we had hoped that we would have more of our graduates tested and licensed. The Nursing & Allied Health Department submitted 10 CNA applications to test for the National Nurse Aid Assessment Program (NNAAP) exam in December 2019. To date, all 10 applicants have been approved by GBNE and are anticipating a test date. However, as a result of the Governor's declaration for a Public Health Emergency due to the COVID-19 pandemic all testing schedules were cancelled until further notice. We reached out to all of our students and notified them of the cancellation due to the pandemic.

Despite the delay in testing, our graduates were provided with the opportunity to utilize their CNA skills and apply for Emergency Temporary Work Permits through the Health Professional Licensing office (HPLO) in order to respond to the Public Health Emergency Declaration. Four of the applicants are currently in possession of emergency TWP's. One currently works at GRMC, one is working for the Department of Public Health and Social Services (DPHSS) and two are processing their applications for DPHSS.

The Department continues to reach out to the remaining applicants to facilitate their ability to prepare and successfully pass the licensing exam. Additionally, nine of our CNA graduates have utilized the ability to use their CNA license to work for DPHSS and one chose to work at GMHA to respond to the emergency declaration.

Student Attrition & Pass Rates

As shown in the table below, attrition for NU101 has improved over the past few semesters. There has been no update to this table since the submittal of the Bi-Annual Report on December 31, 2019.

The table above shows the pass rates for the reporting period. However, there are no updates to this table since the submittal of our Bi-Annual Report on December 31, 2020. As soon as we are notified of the next test date the department will work closely with our students to facilitate their success for testing and passing the CNA exam for local licensing. Online resources have been purchased for all of our graduates so they will be able to continue to independently review and prepare for the exam.

Program Resources

For the reporting period, the Nursing & Allied Health Department has offered the NU101 Nursing Assistant courses:

- 2019 Fall Semester August 14, 2019 – December 2, 2019
- 2019 Spring Semester January 9, 2019 to May 6, 2019
- 2018 Fall Semester August 15, 2018 to December 3, 2018

We are preparing to offer the next CNA course this coming fall semester, 2020. Lectures and laboratory practice for the course will occur in the Anthony A. Leon Guerrero Allied Health Building (3000). There are two nursing classrooms located on the second floor. Each classroom holds a capacity of 40 students. Additionally, there are two laboratory classrooms which consist of a total of eight patient simulation stations. The department will follow all COVID-19 guidelines as outlined by the Department of Public Health and Social Services for educational institutions. The fall semester course will be taught using a mix of remote learning for lecture courses and in person laboratory practice utilizing the use of proper PPE's and social distancing

measures. In person clinical practice will take place at GMH or GRMC pending approval and availability from the clinical agency. The students & faculty will also follow any additional COVID-19 guidelines outlined by the clinical facility regarding clinical practice for students in the hospital.

Currently, the College has an existing MOU between the Guam Memorial Hospital as well the Guam Regional Medical City and the GCC Nursing and Allied Health Department. The GMHA MOU is set to expire on September 30, 2020. A request to renew the MOU with Guam Memorial Hospital has been submitted to GMHA Nursing Administration on July 22, 2020.

Faculty

Ronny Pro Espina was the lead faculty and clinical instructor for the both the Fall 2018 and Fall 2019 semesters and served as the adjunct clinical faculty member for the Spring 2019 cohort. Ronny Pro Espina is a registered nurse who has been serving as an adjunct faculty member for the CNA course since 2017. He received his Bachelors of Science in Nursing from the University of Guam in 2013. Additionally, Loressa Melegrito was the adjunct clinical faculty member for the Fall 2018 semester. Loressa is a registered nurse who received her Bachelors of Science in Nursing from the University of Guam in 2004. She was once a full time faculty member of the PN program from 2010 to 2015 and has been an adjunct faculty member since 2015 to current.

Rosemary Loveridge was the lead faculty and clinical instructor for the Spring 2019 semester cohort. Assistant Professor Loveridge is a Registered Nurse who holds a Master's Degree in Nursing from the University of Phoenix. She has been employed with the Guam Community College for almost fourteen years. She has taken the lead to develop and instruct CNA review courses for the students and has also mentored other adjunct faculty to assist as instructors for the CNA review. There were no new faculty members for this reporting period.
