Personal Interviews: Dr Rapadas provided the testing participants listed below with an overview of the dental exam, which will be held on 23-24 August 2022 at the Dededo Dental Clinic. <ul style="list-style-type: none"> ● He provided in some detail what they are expected to demonstrate on their knowledge of the oral diagnosis (day 1) and operative (day 2) cases, such as proper diagnosis, dental treatment plan, proper preparation/isolation, basic dental procedures, etc. ● He recommended that they also have a back-up case ready to present. ● They would need to take and pass the jurisprudence exam (except Dr. Lee, who already passed the exam); exam has approximately 50 questions. ● They are required to bring all of their supplies for the clinical exam. 	<ul style="list-style-type: none"> ● Dental Assistants would require to be licensed or have a temporary license in order to assist. ● The five (5) GBED members plus 4 additional dentists will participate in rating and they would need a total of 5 positive ratings to pass the exam. ● Emphasized the importance of patient selection for the testing. ● Patients will need to sign waivers. ● For the clinical portion for oral diagnosis, the most recent x-rays and models are preferred. ● X-rays will be taken by applicants on the first day, while x-rays should be brought for the second day. NOTE: A full mouth x-ray would be acceptable. ● Reasons to fail exam: demonstrate substandard performance; GBED is looking for quality and safe dental practices. ● In the event an applicant needs to reschedule exam, next available exam will be in February 2023 ● Dr. Han: Practice Plan to be determined. Needs to bring all legal documents for evidence to be authorized to work and be licensed in Guam. ● Dr. Cha: Practice Plan - Dededo Dental Clinic ● Dr. Lee: Practice plan to be determined. ● Dr. McKeever: Practice Plan - SDA Clinic ● Dr. Suzuki: Practice Plan - to be determined.
