	<p>Chair stated that the purpose of the business needs to be changed. She stated that the business intends to change the description of the business. Ms. C. Fejeran, Baddies & Goons, informed the GBBC that she had followed the required process to obtain a license and stated that the GBBC may be following an outdated process. For instance, per Department of Revenue and Taxation, she stated a business must first obtain an administrative business license in order to establish a place of business and before it could be inspected. Once inspected by the government entities, then the business license will be updated to properly reflect the description of the business. Further, per her read and understanding of the law, the GBBC is to approve the application before there is a requirement to conduct a sanitary inspection. As a result of the delay in GBBC's approval, there was a costly financial consequence; therefore, she recommended that the GBBC verify the application and inspection process to ensure its rules and regulations are compliant with the mandated requirements and, if not, suggested the GBBC update its rules and regulations.</p> <p><i>Motion to approve: A.
