### CALL TO ORDER

The Guam Board of Medical Examiners Chairperson, Nathaniel Berg, MD called the meeting to order at 4:10pm on April 12, 2017 at Guam Memorial Hospital Board Room

## II. REPORT:

## CHAIRPERSON'S:

- Dr. Berg asked the board to right away discuss the complaint put forth by the Board of Cosmetology regarding Ms. Villasenor's practice of doing "vampire facial". The board chair made this since a number of Board of Cosmetology members are present during this meeting.

She also added that she's not yet fully licensed here on Guam but carries an apprentice license. She added that she does not do "vampire facial" to customers but have only been doing to friends and coworkers without compensation.
