- -The SOP is completed and will be voted on during Old Businesses for approval.

V. Old Business

A. Educator Misconduct

- B. Formal Election of Officers for 2022/23

- -Ms. Chelsey San Nicolas has been nominated and accepted as Treasurer. Motion to accept made by Dr. Baza-Cruz, seconded by Dr. Cajigal. No objections. Approved as treasurer.
- -Vice Chair nominee Dr. Lisa Baza-Cruz, to continue holding said position. Dr. Cooper-Nurse moved to accept Dr. Baza-Cruz, Dr. Cajigal seconded motion. No objections. Approved as Vice Chairperson.
- -Ms. Abaday will continue in the position as Chairperson of GCEC. Dr.Baza-Cruz placed the motion, Dr. Cajigal seconded motion. No objections. Approved as Chairperson.
- C. PRAXIS: Japanese World Language Test (5661)
- PRAXIS: Japanese World Language Test (5661) -Discussed in last meeting, motion to approve made by Dr. Cajigal, seconded by Dr. Baza-Cruz of accepting World Language Test (Japanese) in regards to test and score. All approved.

D. SOP 2022.01

VII. Ex-officio

- -Ms. Faisao mentioned 40 vacancies for classroom teachers, as well as a strong need for CHamoru and Special Education teachers. The CHamoru teachers are retiring and there are no teachers coming in to replace them. Dr. Aguon mentioned Chamoru teachers have applied for the Yamashita and Teach grant. Hardship is the funding. Morale is low because teachers are not deemed fully certified teachers, but if they complete the Masters the bump in pay will be significant. Regarding SpEd, there is no longer a degree offered at UOG. Most of the program graduates stayed in the regular classrooms instead of moving to SpEd. All commented it is a financial funding issue. Ms Abaday recommends a letter by GDOE to request funding to take MAT for those not certified.

- -Dr. Aguon mentioned that out of 6 faculty positions that are open, only 1 was approved due to funding.
