Pecina is the only DPHSS official who has access to the data base. HPLO will query the NPDB at the GBED's request.</li> <li>HPLO attempting to connect with the National Board of Dentistry to facilitate access.</li> <li>HPLO will only submit at-fault violations to the NPDB upon direction of the GBED; however, if a licensee is under investigation, but does not renew their license, then the licensee will be reported to the NPDB</li> <li>NPDB is managed by HRSA</li> <li>The general public does not have access to the NPDB</li> </ul> </li> <li>HPLO intends to do media campaign to healthcare providers to educate them on the NPDB and duty to report malpractice suits to the NPDB and the GBED.</li> <li>Although the courts do not have a requirement to report malpractice suits to the DPHSS, applicants renewing their licensee are obliged to report any adverse actions in process or concluded.</li> </ul>	HPLO	1528	Noted
