VI	Nursing Education	Indiana State University During the meeting, members revisited a prior discussion concerning the implementation of a 100% simulation clinical component and emphasized that progress could not be made without first establishing appropriate rules and regulations. Dr. Varghese noted that no communication had been received from relevant parties, nor had the board reached out, as it was deemed unnecessary in the absence of finalized regulations. G. Woodard questioned the urgency of the matter, pointing out that UOG already operates similar programs, and suggested delaying further action until there is a stronger demand. When asked whether the issue should remain on the agenda, consensus formed around removing it for now and revisiting it during the broader review of Article 6 regulations. VIII	Old Business	1. GBNE-CO-20-007/1, 2, 3, 4, 6 & 7 Received 9/16/20. G. Woodard provided an update indicating that an application had been submitted for funding to engage an outside entity to review this case, which would remain on the agenda until either a third-party opinion is received or the statute of limitations expires. Progress was acknowledged to be slow, described as "moving at the speed of government." B. Sablan brought an additional matter before the board regarding complaint number CO20-007-1. It was clarified that the complaint involves unnamed nurses, making it impossible to conduct a proper investigation. G. Woodard gave further clarification and confirmed that while other individuals were identified through a CMS investigation, the individual in number seven, was not identified. Given the lack of identification, He moved to omit complaint number seven from the case, recommending that this portion of the complaint be dropped due to the absence of a named licensee. VIII	Old Business	A. Appointment of Advisory Committee The board engaged in a detailed discussion regarding a proposed advisory initiative intended to support the orientation of newly appointed members. B. Manzana explained that the recommendation stemmed from the reality of board member turnover and emphasized the importance of ensuring continuity. The concept involved having a predecessor, or an experienced former board member, guide the incoming member through the transition process to help them navigate their new responsibilities effectively. This support, she explained, would be temporary and focused on preserving institutional knowledge during transitional periods. M. Gay questioned the need for formal involvement from previous members during official meetings, suggesting that new board members typically learn through direct experience and informal mentorship. B. Manzana shared her personal experience in which her predecessor played a vital role in preparing her for her duties, suggesting that a structured orientation process could be beneficial. 	G. Woodard acknowledged the intent behind the proposal but cautioned that formalizing such a process might create additional administrative burden. He shared that in his own experience, the transition had been informal and dependent on support from executive officers, recognizing that while learning by doing is often necessary, any effort to ease the transition for future members could be worthwhile. B. Manzana agreed that the proposal may not need to take the form of a formal committee or permanent program, but rather serve as a flexible, temporary mechanism for a "warm handoff" between outgoing and incoming members. The board agreed that further consideration was needed to determine the structure and timeline, and they welcomed additional suggestions to refine the initiative and ensure it serves its intended purpose without becoming unnecessarily burdensome. Dr. Varghese expressed appreciation for B. Manzana's initiative but aligned with concerns raised by M. Gay, emphasizing that informal orientation and training are already in place and sufficient. She noted that upon appointment, GBNE and HPLO staff provide ample guidance, including a formal orientation session attended by all board members, which effectively covers foundational responsibilities. While acknowledgeing the complexity of investigations and disciplinary matters, she stressed that such knowledge is often gained through experience and external training, some of which board members have had the opportunity to attend. Dr. Varghese also voiced practical concerns about the feasibility of acting as an advisor after leaving the board, particularly given the voluntary nature of their service. She advocated instead for a more flexible, informal support system, rather than establishing a standing committee or formal advisory structure. G. Woodard summarized the discussion by acknowledging the intent behind the proposal and recognized the value of easing transitions. However, he noted that the board already engages in such informal mentorship, and for			
	B. Impaired Provider Program The board discussed the development of an impaired provider program, with G. Woodard reporting efforts to gather and adapt policies from other states to fit Guam's regulatory context. A key challenge identified was securing an independent agency to conduct required monitoring—such as drug screening and counseling—for a period of two to three years. Although three potential agencies were identified, none had responded to outreach attempts. The intent is for licensees to cover the costs of their own monitoring, with the independent agency reporting non-compliance directly to GBNE, prompting any necessary disciplinary action. Dr. Calalo asked whether the board would bear any financial burden, it was clarified that the licensees would be solely responsible for paying the agencies. A broader conversation followed about the philosophical approach to handling impaired providers. G. Woodard questioned whether the board wished to continue handling such cases individually or pursue a structured program, expressing a preference for a rehabilitative path that supports safe reintegration into practice. 		B. Manzana noted that the NCSBN portal provides established pathways and guidelines for addressing impaired providers, which many states follow. She offered to circulate relevant NCSBN materials for the board's review via email. G. Woodard supported this direction, stressing the importance of balancing public safety with compassion for affected licensees, and highlighting the potentially severe personal consequences of punitive-only approaches.
