



 - b. Tabled. Pending further exploration of this matter.







Guam's Poet Laureate, Frederick B. Quinene, dies at age 77

The man who former Gov. Ricardo J. Bordallo said was "blessed" with the gift of poetry and whom he declared as Poet Laureate of his administration has died.

The University of Guam Press sent a press release, saying they are "deeply saddened" by the death of Frederick B. Quinene who died at the age of 77.

"Through his poetry, Mr. Quinene has touched many lives, and has been a powerful voice for Guam," the release states.

On Aug. 4, 1986, Bordallo named Quinene Poet Laureate, stating: "Fred Quinene has been blessed with the gift of a poetic pen, and possesses the ability to write beautiful, lyrical sonnets ... and this gift should not go unnoticed and is most certainly a source of pride for

According to the press release, UOG Press worked with Quinene in the production of his poetry collection "An Islander's Voice."

"As a proud islander, Mr. Quinene shared his unique perspectives on love, life, family, culture, and Guam politics in his poems. Mr. Quinene's thoughts naturally occurred in poetic form, he once shared. He recalled fishing as a young boy and seeing the world around him transform into rhymes as he would write poems in his mind while at sea," the release stated.


He had shared once with UOG Press Managing Editor Victoria-Lola Leon Guerrero: "Before I even went to school, I was doing, 'Roses are red, violets are blue, you can beat me, but my dad can beat you, or something like that."

Quinene took his poetry to the floor of U.S. Congress, where he read, "What Am I?" - a poem that details Guam's colonial history and questions the people of Guam's representation and citizenship. The poem ends with a statement evoking Guam's maturity:

I do believe my Uncle Sam, that I am mature enough right

that I can decide my destiny, for you yourself have shown me how.

Final respects will be held for Quinene from 8:30-11:30 a.m. Sept. 6 at San Dimas Catholic Church in Merizo. Mass of Christian Burial will be offered at noon, followed by the interment at the Merizo cemetery. (Daily Post Staff)

Efforts to protect Serianthes nelsonii earns award

Following a series of concerns of the ailing population of the local Serianthes nelsonii, University of Guam Center for Island Sustainability Associate Director Else Demeulenaere gained international recognition for her research and efforts to protect the tree.

"I hope to advocate for the need to have more local laws to protect our natural and cultural resources on Guam," Demeulenaere said.

Demeulenaere has been researching the critically endangered hayun lågu, or Serianthes nelsonii. Her efforts were rewarded during the 2019 Botany Conference in Tucson, Arizona, according to a UOG press release.

The conference in late July gathered some 1,200 plant scientists from around the world to network, share their research and acknowledge some of the most impactful works in the field, the release stated.

More Americans will die after Trump abruptly ends **Afghan talks, Taliban say**

KABUL/WASHINGTON (Reuters) - President Donald Trump's decision to cancel Afghan peace talks will cost more American lives, the Taliban said on Sunday while the United States promised to keep up military pressure on the militants, in a stunning reversal of efforts to forge a deal ending nearly 20 years of war in Afghanistan.

The Islamist group issued a statement after Trump unexpectedly canceled secret talks planned for Sunday with the Taliban's major leaders at the presidential compound in Camp David, Maryland. He broke off the talks on Saturday after the Taliban claimed responsibility for an attack in Kabul last week that killed an American soldier and 11 others.

Zabihullah Mujahid, a Taliban spokesman, criticized Trump for calling off the dialogue and said U.S. forces have been pounding Afghanistan with attacks at the same time.

"This will lead to more losses to the U.S.," he said. "Its credibility will be affected, its anti-peace stance will be exposed to the world, losses to lives and assets will increase."

The United States has recalled

U.S. special envoy for Afghanistan Zalmay Khalilzad to chart the path forward, Pompeo said in appearances on Sunday TV news shows. Asked on "Fox News Sunday" whether Afghan talks were dead, Pompeo said, "For the time being they are."

Trump has long wanted to end U.S. involvement in Afghanistan - since his days as a candidate - and American diplomats have been talking with Taliban representatives for months about a plan to withdraw thousands of U.S. troops in exchange for secu-

U.S. and Taliban negotiators struck a draft peace deal last week that could have led to a drawdown of troops from America's longest war. There are currently 14,000 U.S. forces as well as thousands of other NATO troops in the country, 18 years after its invasion by a U.S.-led coalition following the Sept. 11, 2001, al Qaeda attacks on the United States.

Fighting in Afghanistan has continued amid the talks and recent assaults by the Taliban cast doubts over the draft deal. As violence has escalated, Afghan leaders including President Ashraf Ghani have been increasingly critical of the deal and encouraged the Taliban to enter direct talks.

Trump decided to get personally involved to get the agreement to the finish line at Camp David after "real progress" had been made in talks, Pompeo said.

"President Trump ultimately made the decision," Pompeo told Fox. "He said, 'I want to talk to (President) Ashraf Ghani. I want to talk to these Taliban negotiators. I want to look them in the eye. I want to see if we can get to the final outcome we needed."

Pompeo says Trump made the call to hold Camp David Taliban talks

WASHINGTON (Bloomberg News) - Secretary of State Michael Pompeo distanced himself from President Donald Trump's abandoned plan to host Taliban leaders at Camp David, as criticism mounted that the White House was prepared to welcome the group on U.S. soil so close to the anniversary of 9/11.

In several television interviews on Sunday, Pompeo said there'd been intense discussion around the idea of hosting the Taliban, along with Afghan President Ashraf Ghani, at the presidential retreat in Maryland.

The plan centered on efforts to pin down a deal that would have resulted in U.S. troops withdrawing from Afghanistan in exchange for security guarantees from the Taliban. Trump announced in a series of tweets Saturday night that he had called off the meeting.

"President Trump ultimately made the decision," Pompeo said on "Fox News Sunday." "He said, 't want to talk to President Ghani. I want to talk to these Taliban negotiators. I want to look them in the eye."

Of the startling revelations from Trump about the previously unreported talks, the one that attracted the most criticism was the idea of hosting Taliban leaders - whom U.S. officials have branded terrorists - in the U.S., particularly just a few days before the anniversary of the attacks on the U.S. on Sept. 11, 2001.
