Youth bowling league resumes

After a years-long hiatus, a youth bowling league and program resumed at Central Lanes Bowling Center Saturday.

The program is supported by Central Lanes, Pin-Point Guam and Storm Products Inc. it's coordinated by Joey Miranda III, who coaches, along with a handful of other bowlers under the Guam Bowling Congress.

Organizers had hoped to get more than the 15 bowlers who showed up and coaches expect more bowlers to come out this weekend, said Jay Leon Guerrero, one of the coaches.

"We want to build a pool of players to represent Guam for the future," said Leon Guerrero. "We are hoping to get more from the high school league."

Leon Guerrero coordinated the recent high school league. It was a success, with several schools entered, represented by scores of players. It was an additional stage for

star bowler Evan Duenas, who averaged 230 for the season, and it led to the discovery of new talent, such as Xavier Calvo, who bowled a 200 in the finals of the preliminary round to finish just a few pins away from a medal.

The youth league and program is open to anyone 20 years old and under. Interested players need nothing other than an interest in the sport and a willingness to learn.

Players go through about an hour's worth of class-

room instruction, followed by 90 minutes of bowling under coaches such as Darrell Scott, Maria Wood, Ricky Duenas, Cameron Santos and Justin Mendiola, in addition to Miranda and Leon Guerrero.

Leon Guerrero, who has ranked among the best bowlers in Asia, said he hopes to build a team in time for the Asian Schools Tournament next year, an 18-and-under tournament featuring the best juniors from around the Pacific

"The last time Guam joined that, we finished in fourth place, which is pretty awesome," he said. "We want to go back to that tournament next year and this league will help develop that team. Hopefully we can get a girls team too. There were a couple of girls from Saint Paul showing real big improvement in the high school league."
