

# Rodgers plans to play for Jets

Aaron Rodgers said Wednesday he intends to play for the New York Jets in 2023 after 18 seasons in Green Bay and the four-

time NFL MVP quarterback is waiting for the Packers to trade him.

The 39-year-old Rodgers, speaking during an appearance on "The Pat McAfee Show" on YouTube and Sirius XM, said he believes the Packers want to move on and make 2020 first-round draft pick Jordan Love their starting quarterback.

"At this point, as I sit here, I think since Friday I've made it clear that my
