

Approval of Licensure Renewal Form Regarding the approval of the licensure renewal form, it was decided that a meeting would take place at the end of the current meeting at GRMC to review the forms, negating the need for immediate approval due to required corrections and additions. During the meeting, it was confirmed that this review would be conducted in person. Dr. Balajadia noted that the meeting time would depend on traffic, and K, San Nicholas's office would be the location for this review. Dr. Chong was invited to attend, if possible, despite his patient schedule. A suggestion was made to simplify the application process, and there was a discussion about the necessity of a current photo for license renewal. Dr. Balajadia explained that a photo was required according to HPLO administrative rules for proper identification. Another suggestion was to use a driver's license ID instead of a photo for renewals, but Dr. Balajadia clarified that new applicants must comply with passport requirements, while the office prefers a passport-sized photo for renewals. It was also suggested that the license indicate whether the practitioner is focused on acupuncture or acupuncture-oriented medicine, marked as AC or ACOM, respectively, which was noted and confirmed as being implemented in the licensing list.</p> <p>C. Complaints & Investigation Process A document from the Administrator had been sent to everyone, which was found to be very helpful in clarifying the responsibilities and the process for submitting complaints. This document helps to eliminate confusion about who is responsible for handling complaints and outlines the duties of board members. There was a query about whether this document is part of the new law or rules and regulations. M. Balajadia confirms that it originates from the HPLD rules and regulations.</p> <p>D.
