The Board mentioned a concern with the establishment called "360" that may be practicing without proper licensure. Dr. Miller raised concern about wellness businesses that are providing massage services that require no education. Dr. Miller is worried that some of these businesses might begin to expand their scope of practices without the proper clearances or licenses. The Chair stated that the statute requires acupuncture and oriental medicine to be licensed by the Board. Dr. Miller suggested that certified mail be sent to establishments that are violating the statutes, issuing a cease-and-desist order. Press releases are also being worked on by HPLC.
