

Pecina reported the following:</p> <ul style="list-style-type: none"> Based on a discussion with the attorney, she recommended the Board remove the sanitation fees since it is already encumbered by DPHSS Budget. She requested that the Treasurer work with her on the fees. Asst AG Daniel Morris has been assigned to the Board, who will assist in the review of the Rules and Regulations. Board composition: still pending approval for a public member as well as a youth member. The website is still in progress, where applicants will be able to submit application for licensure on-line, which is expected to be fully functional this summer. Working with the national office to implement remote testing at home or at HPLO. Working with Senator Muna-Barnes to get constituents up-to-date and waiting on more details. B. 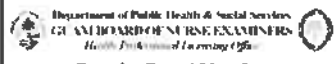

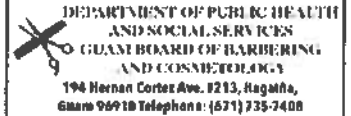
