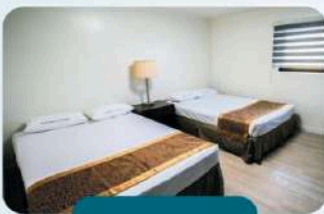

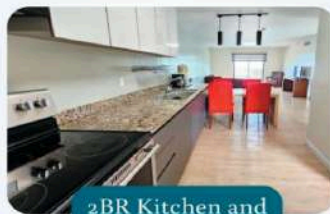

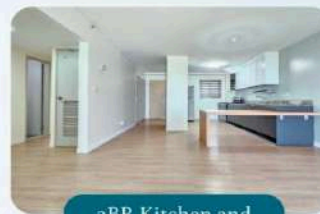
Interior Layout
