The Missile Defense Agency Welcomes Public Comments on the Draft Environmental Impact Statement for the Enhanced Integrated Air and Missile Defense System on Guam
 The Missile Defense Agency (MDA) in cooperation with the United States (U.S.) Air Force, U.S. Army, U.S. Navy, and the Federal Aviation Administration has prepared a Draft Environmental Impact Statement (EIS) for the Enhanced Integrated Air and Missile Defense (EIAMD) System on Guam. The Draft EIS includes an analysis of the potential environmental impacts that may result from the proposed construction, deployment, and operations and maintenance of the EIAMD system to defend Guam against advanced missile threats (Proposed Action). Mitigation measures that could avoid, minimize, or mitigate potential environmental impacts of the Proposed Action are also analyzed in the Draft EIS.
Draft EIS Public Review and Comment Period Open Through Jan. 8, 2025
 The MDA and cooperating agencies welcome substantive comments on the environmental impact analysis and the project's potential to affect historic properties under Section 106 of the National Historic Preservation Act (NHPA). The Draft EIS is available on the project website for download or in print at the University of Guam and the Nieves M. Flores memorial libraries. The MDA held two public meetings on Guam in November 2024 to inform the public about the Proposed Action and the environmental analysis, and to solicit public comments on the Draft EIS.
