It was acknowledged that certain jurisdiction-specific requirements, particularly those related to cultural competency tailored to the island communities, may pose challenges for these providers. Despite these concerns, prior licensing approvals for similar cases were noted. A. Lape emphasized ongoing efforts to clarify cultural competency standards within the board's rules and regulations. It was agreed that these clarifications are necessary to ensure proper guidance for telehealth providers licensed through the board. Furthermore, the board recognized that the issue ties into a broader, ongoing national dialogue about license portability, which they generally support.
