

are issued every five years, the most recent, published in 2022, which used data from 2013-2017, identified the top cancers on Guam as breast, lung and bronchus, colorectal, prostate, and

The report showed that lung and bronchus cancer was the leading cause of cancer-related deaths; and while breast cancer rates on Guam are lower than on the U.S. mainland, rates of cervical and liver cancer are significantly higher.

Data entry for 2023 cases is now complete, and a new five-year report (2018-2022) is in development.

Research collaborations

Through the U54 Pacific Island Partnership for Cancer Health Equity partnership between UOG and the University of Hawai'i Cancer Center, UOG researchers have attracted over \$171 million in grants and published 157 peer-reviewed studies. Besides us co-leading the grant, eight other UOG faculty and administrators support it.

Recent cancer research projects led by UOG faculty include:

- Obesity and Cancer Survivors: This year, Tanisha Aflague, PhD, is concluding a pilot intervention study to reduce obesity among female breast cancer survivors in Guam and Hawai'i.
- Breast Cancer Risk: Grazyna Badowski, PhD, explored the role of clinical risk factors and breast density in breast cancer screenings to identify trends in the prevalence of breast cancer risk among Asian and Pacific Islander wom-
 - Botanicals and Cancer:

Sahena Ferdosh, PhD, investigated bioactive compounds in poha (Physalis peruviana) and soursop (Annona muricata) for their potential in combating a key bacterial pathogen associated with colorectal cancer.

• Betel Nut Use: PIPCHE researchers developed educational campaigns, including a school-based curriculum and social media outreach, to reduce betel nut and tobacco use, substances linked to oral and liver cancers.

Representation in cancer research and data collection matters. Including Pacific Islanders in cancer data and studies is vital to reducing health disparities and investing in health care solutions tailored for island communities.

Research at UOG

The Guam Cancer Research Center is supported by UOG's Office of Research and Sponsored § Programs, which oversees grant acquisition and research initiatives across UOG's nine research centers. Programs, which oversees
