



missed, leaving the score at 6-0.

Another defensive stop gave Southern the ball back, and Tablan broke loose for a 41-yard run, setting up his own 3-yard touchdown reception.

Kaden Cruz added a two-point conversion to close the quarter at 14-0.

2nd quarter surge

The Dolphins continued their dominance in the second quarter. Atoigue's forced fumble was scooped up by Acovera, who sprinted 34 yards to the end zone, extending the lead to 20-0.

Johnnie Brub added a 2-yard touchdown, pushing the score to 26-0.

The Sharks finally responded with a spark of their own.

Jeremy Salinas returned a kickoff 75 yards for a touchdown, cutting the deficit to 26-7. But Southern answered immediately.

Gaje connected with Tablan for a 77-yard touchdown, sending the Dol-

phins into halftime with a commanding 32-7 lead.

Second half highlights

Sanchez came out strong in the third quarter, as Jude Kelly intercepted Gaje and returned it for a touchdown.

However, Atoigue

blocked the PAT, keeping the score at 32-13.

The Dolphins weren't done yet. Gage and Tablan linked up once more for a 53-yard touchdown, their third of the night. A failed two-point attempt left the score at 38-13.

The Sharks managed a late 25-yard field goal by Tristan Parks to bring the final score to 38-16, but the damage had already been done.

Christopher Leon Guerrero led the Sharks with 9 carries for 68 yards.

Jude Kelly had two interceptions and six tackles for Sanchez's defense.

Tablan was the leading rusher for Southern as well with 50 yards on only 3 carries.

Postgame reflections

"This game was just a preview of what we have in store this season," Atoigue said. "We need to work harder for the upcoming teams, stay humble, and we got more to come."

Tablan echoed the sentiment.

"Even though me and my freshman quarterback [are] different grades, we still got that chemistry that we want to build up, and we're looking forward to the season," Tablan said.

The Dolphins will take on the Okkodo Bulldogs in Week 2 next Saturday at 3 p.m. at the Okkodo Field, while the Sharks face the FD Friars next Saturday night at the GW Field.

"I was raised with the Chamoru culture throughout my childhood from my dad Kyle Flores, grandmother Julia Fejeran and my 2nd grandmother Rita Lujan," said the 18-year-old Fox-Flores. "They have always taught me that family comes first and respect everyone and trust in God. I am very proud to be Chamoru and humbly represent the island Guam everyday."

With his first career college reception under his belt, Fox-Flores looks forward to a bright future despite the Bruins starting the season 0-2.

It'll be a tough road ahead as they have No. 1 Ohio State and No. 2 Penn State on their schedule.

The sky is the limit, however, for the young and talented tight end with Guam roots and Guam pride.

Readers may know his grand uncle-Larry Fejerman, the long-time basketball referee and part of the historic 1979 South Pacific Games basketball gold medal team.

"I remember when he was a little boy he would always play football with his cousins, uncles, and his dad," Uncle Larry said. "So I believe he had thoughts of getting somewhere with it. I believe he saw his dad was an athlete which had to inspire him to be an athlete also. With the support of his parents he continued working towards this dream and I'm very surprised and even more proud of where my nephew is today. I truly believe his grandmother would be so proud of him and his accomplishments."

Despite not having visited Guam yet, Fox-Flores and family have definitely embodied the CHamoru culture and spirit.

"What I really love about him and his sister (Kyona) is their respect for people. Something his great grandmother taught me and passed on to our kids and

grandchildren," Uncle Larry added.

The Fejeran athletic clan includes grand uncle Kin Fejeran, who stood 6-foot-1 and was part of the 1975 Guam SPG basketball team and also played tight end for the 1970's UOG Tritons.

Offers

The Bruins are part of the Big Ten Conference, which actually has 18 football teams.

Fox-Flores had offers from the following schools: Penn State, Michigan, Oregon, Washington, Louisville, UCLA, Cal, Oregon State, Hawaii, Texas A&M, Tennessee, Washington State, Arizona State, Arizona, and Idaho.

The last CHamoru player known to play in this conference was Zach Banner with the USC Trojans, 2013-2016.

Banner went on to get drafted by the Indianapolis Colts and spent time with the Cleveland Browns and Pittsburgh Steelers before injury cut his NFL career short.
