points.

Takumi Simon had the hot hand early and finished with 15 points, while Mark Johnson Jr. contributed 14 points, seven rebounds, and four assists for Guam.

On the basketball end, it was a growing experience, but they all said they had a bigger responsibility to represent Guam well and showcase the islands positively to everyone they met.

"Our opponents were always respectful. I think that it was our team's role to represent the island, not only for basketball, but also our sportsmanship and the island's respectful culture," Maddy Ada said.
