IV	HPLO Administrator's Report The board discussed the recent passage of Bill No. 24-38, known as the Emergency Contraception for Survivors of Rape Act. B. Salan reported that the bill became law earlier in the week, emphasizing access to emergency contraception for rape survivors, particularly in emergency settings. Concerns were raised that stakeholders, including relevant boards, were not invited to the hearing and did not have an opportunity to review the bill prior to its enactment. Specific comments were made by M. Gabriel regarding the definitions within the legislation, particularly in Section 98101, which defines emergency contraceptives solely as prescription drugs. Clarification was suggested to reflect the current availability of certain emergency contraceptives like Plan B, which has been approved for over-the-counter (OTC) use without age restrictions since 2013. Recommendations included broadening the language in the bill to include both prescription and non-prescription options, such as copper IUDs and various pill-based methods, and	M. Gabriel	0742	Noted

		avoiding overly specific dosage information to allow flexibility as medical standards evolve. Further discussion addressed Section 98102C, which refers to a follow-up dose that may no longer be necessary under current single-dose regimens. The board advocated for more general language in this section to reflect up-to-date practices. Another concern involved the act's immediate effective date. It was noted that while the law is now in effect, facilities would need time for procurement, policy updates, and committee approvals to add medications to their formularies. The implementation timeline was seen as too abrupt for facilities to comply meaningfully with new requirements, particularly given the need for internal approvals and policy development. The board also questioned whether a formal letter should be sent to the senator to provide feedback and recommend clarifications or amendments. B. Sablan supported the idea of drafting and delivering a letter, both physically and via email, and continuing to follow up. It was hoped that, in the future, boards such as the Board of Pharmacy would be invited to participate before such laws are finalized, minimizing the need for amendments after enactment. The board agreed to begin drafting the letter, with a commitment to collaborate and proceed with the correspondence promptly.

		IMPRIMIS NJOF, LLC The board continued its discussion on a licensing matter involving a pharmaceutical outsourcing facility that had attended the board meeting to address licensing concerns and respond to questions. Background was provided on the facility's legal ability, under federal law, to compound medications without FDA approval, provided they comply with CGMP. It was noted that compounded medications, particularly those not approved by the FDA, carry certain risks due to their exemption from stringent quality inspections. Concerns were reiterated regarding the company's history of FDA warning letters, with past violations related to CGMP standards, including issues with sanitary conditions and product recalls. Additionally, an open disciplinary case in California was highlighted, involving 16 counts relating to failures in production recordkeeping, test sampling, and complaint handling. Despite these issues, the company remains in good standing with many state boards and continues to distribute medications across the United States. Board members emphasized their concerns with the logistics of shipping temperature-sensitive medications, such as specialty drugs and vaccines, from New Jersey to Guam, suggesting that stability studies be conducted to ensure safe transit. Historically, pharmacies have sourced such medications from Hawaii due to faster delivery times and a strong compliance record. It was	GBEP		Tabled, Pending CA Inspection

	confirmed during the meeting that the anticipated inspection by the California Board of Pharmacy had not yet taken place but was scheduled for mid-September. The facility representatives pledged to share the resulting inspection report and address any deficiencies. Questions were raised regarding whether any other state licenses were under scrutiny beyond California, to which the representative clarified that California was the only state with an open case at the time, and documentation regarding licensing statuses had already been submitted for review. The conversation also touched on FDA warning letters, with participants trying to determine the timeline and status of various inspections and follow-up actions. It was noted that the latest inspection occurred in March 2020 and that previous warning letters dated back to 2003 and 2022. An upcoming FDA inspection in April 2026 was believed to be scheduled to address outstanding findings from 2023, though this remained to be confirmed by the company's head of quality. The board expressed the need for greater clarity and timely updates on both state and federal regulatory matters moving forward. Dr. Lombard joined the meeting remotely to share his perspective as a practitioner who had previously worked with the pharmaceutical outsourcing facility under discussion. He expressed appreciation for the board's diligence in reviewing the licensing matter, while also voicing strong support for the facility, citing its vital role in providing compounded medications specifically for ophthalmology—services he emphasized are difficult to source for Guam-based providers. Dr. Lombard noted that only one other company, OSRX, offers a similar range of compounded products, but that company has declined repeated requests to service Guam. Dr. Lombard reported using products from the facility for approximately two to three years with no patient complaints. He confirmed that the medications ordered were sterile, and he emphasized the importance of patient education to mitigate potential risks of infection or inflammation. He acknowledged the inherent risks associated with intraocular medications but clarified that such risks are not unique to the facility in question, referencing even over-the-counter eye drops that have caused infections in the past. He stated his willingness to implement additional patient education or precautionary measures should the license be approved, especially in light of the company's pending regulatory inspections and unresolved FDA warning letters. When asked about volume, Dr. Lombard explained that his clinic primarily used the facility's products in-office, such as combined phenylephrine and tropicamide eye drops used for dilation, which he estimated they would order in quantities of about 8–10 bottles per month. He also referenced specialized injectable medications used during cataract surgeries and compounded post-operative drops that combine multiple active ingredients, streamlining treatment regimens for patients. He confirmed that the facility shipped directly to his clinic, from which products were dispensed and labeled in accordance with regulations, and not shipped to local pharmacies or directly to patients. Following Dr. Lombard's remarks, board members discussed the clinical convenience of the

		products, noting that while the compounded combinations offered efficiency, the individual components are available commercially through other vendors. The compounded formulations primarily offer a more streamlined and patient-friendly approach, rather than introducing medications that are otherwise unattainable. Nonetheless, concerns remained regarding the safety of sterile products, particularly those requiring cold-chain transport from the mainland, such as from New Jersey. The board acknowledged the unique logistical challenges faced by Guam and recognized the limited vendor options available to ophthalmologists. However, members reiterated that public safety remains the board's top priority. In light of ongoing regulatory concerns and the upcoming inspection by the California Board of Pharmacy, the consensus was that it would be prudent to wait for updated inspection findings and responses to any deficiencies before making a final licensing decision. <i>Motion to table pending September 2025 CA inspection and speaking with the Compliance Officer at the next scheduled meeting : A.
