The new Guam-Cebu-Guam route will operate three times weekly, providing passengers with more convenient travel options, just in time for the holiday season, PAL said in a release on Thursday.

The flight schedule is as follows:

- Guam to Cebu (PR 121) - Departs Guam at 6:50 a.m., arrives in Cebu at 8:35 a.m. on Wednesdays, Fridays, Sundays
- Cebu to Guam (PR120) – Departs Cebu at 3:25 a.m., arrives on Guam at 7:45 a.m. on Tuesdays, Thursdays and Saturdays
