dictated the pace through sharp passing and aggressive play.

In the 26th minute, Islanders' Malcom Ogo broke through the Eagles' defensive line and buried another goal to extend the Islanders' lead to 2-0 before halftime.

"As a midfielder, you don't normally score a lot of goals," Ogo said. "This goal really means a lot to me, especially since it was my first goal of the season."

2nd half

The Eagles regrouped after the break and came out more aggressive in the sec-

ond half.

Their efforts paid off just five minutes in when Eagles' Freshman Seigo Yamamoto capitalized on a dropped ball from the Islanders keeper, slotting it into the net to cut the score to 2-1.

With time ticking down, the Eagles pushed numbers forward, trying to put constant pressure on the Islanders' defense.

The match grew increasingly physical as both teams committed penalties and the Islanders' goalkeeper even picked up a yellow card late in the game.

Still, the Islanders held firm under pressure to protect their narrow lead.

"Even though the other team scored, we never dropped our intensity," Nauta said. "We focused on making sure nothing else got through. We just kept going and played 100% until the final whistle."

Northern Construction secured the #3 seed for the playoffs with a 90-74 victory over the UOG Tritons in the nightcap. The Tritons lost their 6th straight game.

The game started close, as Northern led 22-16 after the first quarter. UOGers played well in the 2nd quarter, just losing the period with 25-23, and trailing at halftime, 47-39, to Northern.

The Tritons finished the

third quarter with several turnovers. Northern Construction outscore UOG, 28-21, to lead 75-60 at the end of the period.

UOG wasn't able to come back as the teams played a close 4th quarter, with Northern winning the quarter, 15-14, and the game, 90-74.

Eric Ruiz led Northern with 30 points and Elmar Morada added 23.

The Tritons were led by Ralph Malalod with 16, while Michael Quinata and

Javen Napute added 15 and 14 points, respectively.

Northern Construction is now 4-2 in the league and is now the #3 seed for the playoffs.

week went on.

"Monti shined as our #1 player, carrying a heavy load in both singles and doubles," coach Smith said.

The coach highlighted Gibson's pivotal role on the team.

"Competing all the way through the tournament really tested both my physical and mental endurance," Gibson said, portraying how each match challenged and helped her grow.

Her focus and grit was an example for the team, setting a standard for performance and resilience as she started strong and finished strong.

Guam rebounded to a strong finish in their final placement tie on Friday against Bahrain, with Mercado leading the way.

She set the tone with her first-ever Billie Jean King Cup singles victory, 6-2, 3-6, 6-2, showing consistency, focus, and determination throughout long rallies and giving Guam an early lead.

"It feels incredible to finish with a win...each match taught me something new, but it also reminds me there's still a lot to learn and

improve on," Mercado said, reflecting on her milestone.

Gibson followed up with a commanding 6-1, 6-4 singles win, stepping into the court more aggressively against an opponent who relied on steady, spinning balls.

She trusted her instincts, disrupted the rhythm, and dictated points when opportunities arose, demonstrating clear growth and confidence by the end of the match.

Doubles excitement

Oh and San Agustin closed out the tie in doubles with a 7-6(5), 6-4 win.

Their match highlighted teamwork and composure under pressure, even as the opposing team took an unusually long restroom

break at 5-6 in the second set, within the rules, but enough to disrupt momentum.

The Guam duo quickly regrouped and finished strong.

"We managed to close it out anyway," Oh said.

San Agustin said the experience gave her a good sense of "how things are at this level."

Earlier in the week against Laos, the pair also competed in doubles, with San Agustin marking her first international doubles match.

They pushed the match to a decisive third-set tiebreak but narrowly fell 1-6, 6-4, 6-10, showing early signs of composure and growth.

Facing opponents who relied on patient, consistent rallies, the Guam team responded with focus, rhythm adjustment, and support for one another on court.

Each player contributed to the team's success coach Smith praised the team's commitment and progress across the event.

"The overall performance was something to be proud of," he said.

With the women's campaign now complete, attention turns to the Guam National Men's Team, who will compete in the Davis Cup in Manama, Bahrain. Following in the footsteps of the women's squad, the men will look to continue Guam's momentum on the international stage.
