Plummer had to close the business and sell the boat in 2024 due to the decline in Japanese tourists after the COVID-19 pandemic.

"It used to be 80% to 90% of my business, but after COVID, I pretty much was out of business," he said.

For the last couple of years, his son and grandson, both licensed captains, were running the business due to Plummer's age and health problems. He was diagnosed with cancer and underwent bypass surgery.

Plummer decided not to pursue further treatment, preferring his grandkids to remember him "on the couch instead of in the hospital."

After 47 years, Plummer's silent legacy is carried on with his former student-athletes and the success of his beloved sport.

Although he has stepped away from the sport and not been able to attend tournaments, he said it fills him with pride and joy whenever he reads about wrestling, track and field, or cross country.

There are more people participating in it [now]," Plummer said. "It makes me feel really good. Not too many people know I started it [because] I don't talk about it too much. My family knows, and students from JFK back then, guys who are 65 years old and have grandchildren, will sometimes walk down street and [yell] 'Coach &

Plummer has also become a well-loved member of his local community. His wife, Trudy Plummer, is originally from the Chargualaf family in Inalahan.

Living on Guam for nearly five decades, Plummer considers himself an island local more than anything else.

"All the kids from the village call me Tata. I've really gotten into the culture with my wife, and my kids are all more CHamoru than they are haole," he said. "Being here so long, I feel blike I'm more CHamoru, seven though I don't speak even though I don't speak the language."
