## 'Royal Friars' dominate the Sharks

The combined force of the reigning champs—Notre Dame Royals and FD Friars -looked every bit like defending titleholders in their sweep of the Simon Sanchez Sharks.

For the Royals, nearly every wrestler came away victorious.

The Sharks' lone girls' win came from 97-pounder Ehvalene Marques, who outlasted Royal Shyloh'rei Phillips to secure the only Sanchez hand-raise of the dual.
