	<p>Dr. Berg reported, he, Dr. Eusebio, and Dr. Aguon will be meeting with the front office to discuss this bill. The goal is to ensure alignment between the front office, GMH, and the board, particularly in preparation for any potential national legislative changes, though such changes are considered unlikely at this time.</p> <p>Dr. Berg also discussed the possibility of utilizing local mechanisms to address critical healthcare needs. One idea under consideration is adapting Washington State's Assistant Physicians Program for GMH, which could help fill gaps while remaining compliant with current immigration and Medicare regulations. There is optimism that with creative thinking and strong motivation, progress can be made. Updates will be shared with the board as developments occur.</p> <p>Additionally, leadership from the Federation of State Medical Boards (FSMB) will be visiting the region. They are expected to arrive on December 4th or 5th, spend a day or two in Saipan, and then travel to Guam on December 6th. Efforts are underway to arrange meetings between FSMB representatives and Guam's healthcare leadership. FSMB has also expressed interest in supporting Palau and Samoa with medical regulatory issues. Dr. Hank Chaudry has indicated that there may be an opportunity to bring representatives from Palau and Samoa to Hawaii for further discussions. He may travel to assist with this ongoing, multi-year effort to integrate these regions into FSMB initiatives.</p> <p>Dr. Berg also highlighted progress on the Health Professionals Program, which aims to support all licensed professionals. FSMB has played a key role in advancing this initiative and has helped secure national attention and support. A dinner is being planned for board members to meet the FSMB delegation, including both the FSMB President and Chair, during their visit to Guam.</p> <p>Looking ahead, the Chair encouraged board members to attend the FSMB Annual Meeting in April, which will be held in Baltimore. While the location may not be particularly exciting, the meeting itself is highly valuable for networking and professional development. Early planning is recommended due to limited hotel availability. Funding and scholarship opportunities are being explored, and further details will be shared as they become available. Dr. Berg emphasized the importance of Guam maintaining a strong presence at these national meetings, noting that the most recent FSMB meeting featured Guam's largest delegation to date.</p>			
	<p>B. Public Law 117-333 Sec. 19. Portability of professional licenses of members of the uniformed services and their spouses.</p> <p>Dr. Berg provided an update regarding a recent issue discussed in the GBME chat concerning military physicians and the application of the Affordability Act. As a reminder, under current Guam law, physicians who are stationed in Guam or are the spouses of those stationed in Guam, are automatically licensed to practice in Guam for the duration of their assignment, provided they maintain a clean disciplinary record and hold an active license in another U.S. state.</p> <p>In one recent case, a military physician received a letter confirming compliance with this law and recognition of their out-of-state license. However, when the physician applied for Medicare and local insurance credentialing, the</p>			Noted

		<p>application was denied due to the absence of a formal Guam license. Upon investigation, it was found that other jurisdictions issue restricted licenses in such cases, clearly outlining the limitations.</p> <p>As a result, the GBME has adopted a similar approach. A formal letter is now issued to qualifying physicians, outlining the following key restrictions: The physician must maintain an active license in another U.S. state; The physician must keep their contact information, particularly email, up to date with the GBME; The license is automatically terminated upon a permanent change of station (PCS), regardless of whether the physician notifies the board; Temporary duty assignments (TDY or TAD) do not affect the license status and do not require notification.</p> <p>To formalize this process, the physician is required to sign an acknowledgment of these terms. Once signed, a restricted Guam license is issued, with an expiration date matching the end of the physician's or spouse's current assignment orders. Military orders are submitted as part of the process, with any sensitive or non-public information redacted for privacy and security.</p> <p>The Chair emphasized that this approach ensures compliance with Guam law while aligning with practices in other jurisdictions. The updated language and process are being shared with FSMB to promote consistency across states.</p>

sports—values that strongly align with the mission of the Department of CHamoru Affairs.

"These Games represent an important step forward in Guam's Indigenous empowerment," DCA President Melvin Won Pat-Borja said. "Our participation strengthens our cultural presence on the international stage and reflects our ongoing commitment to protecting and promoting the Chamorro identity."

GVB General Manager Régine Biscoe said it is an honor for Guam to compete in the World Indigenous Traditional Games, which have brought together indigenous peoples from around the world to celebrate their cultural heritage and compete in traditional sports.

"Our island now has the unique opportunity to connect with our Austronesian ancestry and showcase our culture to the world through our talented athletes," she said. "We also look forward to building more cultural connections through events like the Guam International Dance Festival this December and the Guam Micronesia Island Fair in June 2026."

Gov. Lou Leon Guerrero, in a statement, praised this historic milestone.

"Sending our first delegation to the World Indigenous Traditional Games is a meaningful moment for Guam. This is more than competition. It is cultural pride, it is identity, and it is the continuation of a story our ancestors began. I am incredibly proud of the athletes who will carry Guam's spirit to

Taiwan and share our heritage with Indigenous communities from around the world," the governor said.

Lt. Gov. Josh Tenorio echoed this enthusiasm.

"These athletes are not only representing us on the world stage. They are carrying forward traditions that define who we are as a people. This delegation reflects our island's heart, talent, and cultural

strength. I look forward to seeing Guam's presence shine among so many indigenous nations," he said.

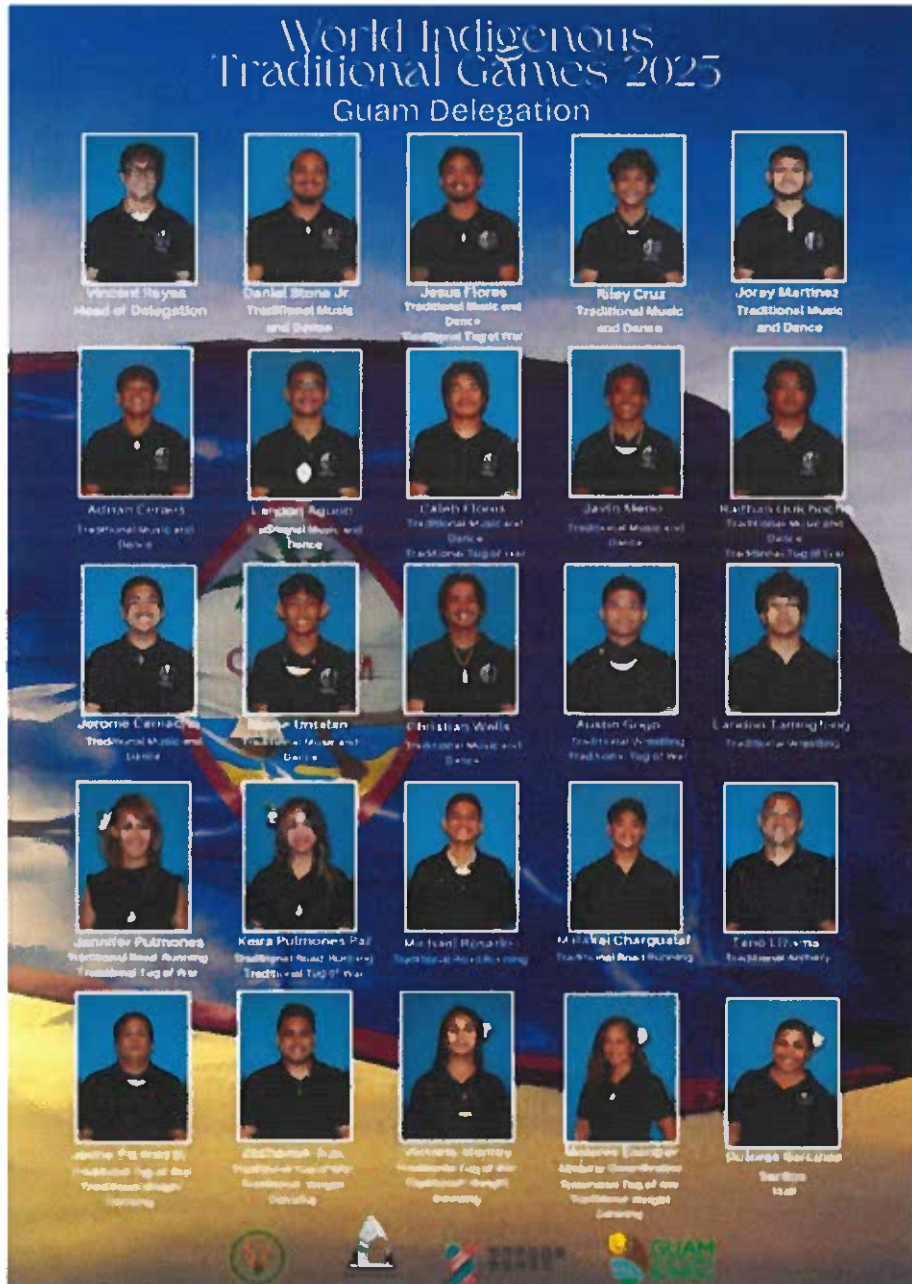


