riors’ half-court defense remained disciplined, contesting shots and limiting second-chance opportunities.

To their credit, the Dolphins showed fight in the second half, putting up 10 points in both the third and fourth quarters.

Matthew Quinata and

Noah Taitague led the way with 10 points each, providing the team’s most consistent scoring.

But the Warriors’ depth and defensive intensity never wavered.

Omar Henser led with 15 points, while Mario Bork and Francis Jones added 10 points apiece, helping the Warriors maintain a comfortable lead throughout the night.

A 19-10 third quarter and a steady 16-14 fourth

sealed the final score at 75-36.

In the end, the Warriors’ full-court pressure was the defining factor, a tactical choice that completely disrupted the Dolphins’ offensive flow and fueled a steady stream of transition points.

It was a statement win for the Warriors and a tough learning experience for the Dolphins, who will look to regroup and adjust before their next matchup.
