**VOLUNTARY RECALL OF LIMITED BATCHES OF GERBER ARROWROOT
BISCUITS DUE TO POTENTIAL PRESENCE OF FOREIGN MATERIAL**

Hagåtña, Guam – The Department of Public Health and Social Services (DPHSS) would like to inform the public regarding the voluntary recall published by the U.S. Food and Drug Administration (FDA) of limited batches of Gerber® Arrowroot Biscuits sold nationwide out of an abundance of caution due to the potential presence of soft plastic and/or paper. These materials can cause choking or mouth injury, especially in young children who are still developing chewing skills.

This recall is isolated to limited batches of Gerber® Arrowroot Biscuits 5.5oz products produced between July 2025 and September 2025. Batch codes can be identified on the back of the product packaging which includes a 10-digit batch code prior to the best before date.

The DPHSS Division of Environmental Health (DEH) has conducted recall effectiveness checks and determined that the recalled products were distributed by off-island vendors and/or sold on the island at the following retailers on Guam:
